This survey is to be conducted online with Victorian-based registered and non-registered building surveyors (BS) and potential BS (included Registered Building Inspectors).

There are more than 500 Registered BS in Victoria in total with 380 ‘practising’ in that they have issued permits in the past 3 years or work as Municipal Building Surveyors who may or may not be issuing permits. There is another group of Registered BS who are not issuing permits believed to number about 120.

The ‘potential’ BS include non-registered, qualified BS working under a senior MBS or a BS in private practice, or those working in government or for a statutory body. These potentials are not issuing permits in their own right. Potentials also include those newly qualified as a BS (but yet to be registered), Building Inspectors (BI, of which there are around 550) and full-time BS students. (Some BI will be studying BS on a part-time basis).

Study notes and sample sources

This survey is to be conducted online with Victorian-based registered and non-registered building surveyors (BS) and potential BS (included Registered Building Inspectors).

There are more than 500 Registered BS in Victoria in total with 380 ‘practising’ in that they have issued permits in the past 3 years or work as Municipal Building Surveyors who may or may not be issuing permits. There is another group of Registered BS who are not issuing permits believed to number about 120.

These potentials are not issuing permits in their own right. Potentials also include those newly qualified as a BS (but yet to be registered), Building Inspectors (BI, of which there are around 550) and full-time BS students. (Some BI will be studying BS on a part-time basis).

A number of sampling sources have been identified for this survey.

- The Building Commission (BC) - for all registered BS and BI in Victoria.
- The Australian Institute of Building Surveyors (AIBS) whose members should include both registered and non-registered BS. Possibly some of these are BI and students (TBC).
- Universities and TAFE Colleges (via BC) for the ‘potentials’ who are BS students or newly qualified (TBC).

For privacy reasons we are unable to obtain access to the AIBS or University and TAFE College databases here but they were happy to send out the survey (link) to their members and students. This means some doubling up is likely to occur but to mitigate this we will:

- Ask AIBS to not include student members (or retirees) in their list of invited members.
- Mention in the covering email that if the same survey invitation has been received from the Building Commission to ignore and delete one of the invitation emails.

Target respondents

There are a number of actual and potential (BS) segments of interest which we hope will emerge naturally in the sample from the BC and AIBS sources.

1. Registered and practising BS who can be registered on either a limited or unlimited basis. These are either in private practice (issuing permits) or they are Municipal Building Surveyors (MBS) who may or may not be issuing permits.
2. Registered and non-practising BS (may be ‘potentials’ but more likely do not want to practice as a BS now).

3. Non-registered, qualified BS who have been qualified for some time (Likely to be working under a Municipal Building Surveyor or under a BS in private practice or for a government or statutory authority). In theory these are 'potentials' but they might not wish to be practising BS.
4. Newly qualified BS (in 2011-12) not registered (yet) and classed as potentials if not yet practising as a BS. (Some of these might fall under group 3 above)
5. BI or Building Inspectors (potentials). These can be registered on a limited or unlimited basis.
6. Full-time BS Students (potentials).

We believe all target respondents can be accommodated in the one questionnaire with appropriate skips programmed in to ensure that questions not relevant to any respondent group were asked of them.

Sample size

More than 550 invitations are expected to be issued to actual BS and a similar number or possibly more to the potentials. We can not predict responses but it is hoped that 150 responses to 200 responses will be received with BS and similar for the potentials.

Location quotas

None are to be set but because we are asking everyone to participate it is expected that the final sample will resemble the actual split of metropolitan and regional / rural based BS and BI. If necessary, results could be weighted to known statistics on this variable (and others).

Covering email

To be sent by BC/AIBS/TAFE/University with a link to the survey. The email would act as a Letter of Authority and should be sent by the Commissioner to give the survey legitimacy and encourage participation. A letter will be mailed beforehand too. Reference could also be made to the AIBS for members approached.

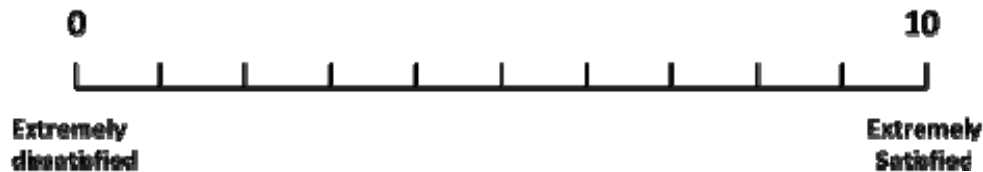

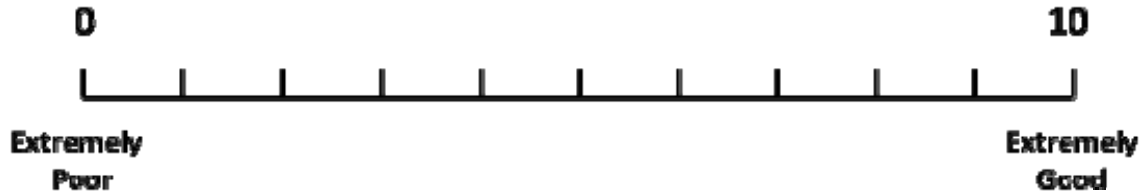

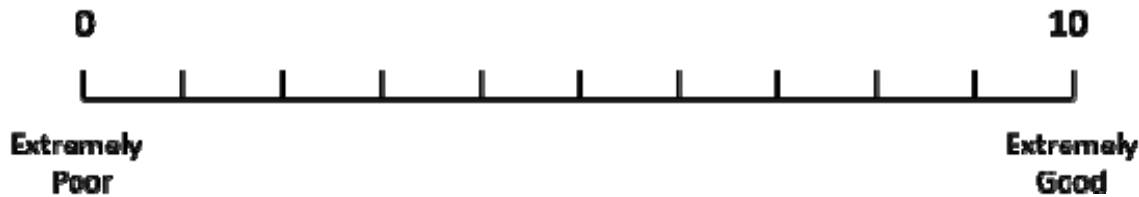
