Applications – There were 553 applications managed in this reporting period, including two (2) review applications. This report provides statistical reporting on the 551 standard applications and separate statistical reporting on the two review applications managed during the reporting period.

Rounding – Where figures have been rounded, discrepancies may occur between sums of the component items and totals shown. Percentages of less than 0.5% are shown as 0%.

GST – All amounts are GST exclusive.

Building and Construction Industry Security of Payment Act 2002

The *Building and Construction Industry Security of Payment Act 2002* (SOP Act) is intended to provide contractors with a quick, inexpensive and non-legalistic way to recover money owed to them and to resolve payment disputes. It applies to construction contracts for work carried out in Victoria.

Adjudicators are nominated by Authorised Nominating Authorities (ANAs). ANAs are authorised to perform this service by the Victorian Building Authority (VBA) under section 42 of the SOP Act.

The functions of an ANA include nominating adjudicators for the purposes of the SOP Act, receiving and referring adjudication applications to adjudicators and providing information to the VBA in accordance with the SOP Act.

ADJUDICATION ACTIVITY STATISTICS REPORT

This report provides tabulated and graphical representations of adjudication data for the 2019-2020 financial year. The information in this report is based on data provided to the VBA by ANAs.

PROVISION OF INFORMATION

ANAs must provide the VBA with information in relation to the activities of the ANA under the SOP Act. Information requested by the VBA may include information regarding the nomination of adjudicators, appointment of review adjudicators, the assessment of eligibility of persons to be adjudicators, the fees charged by the ANA and the fees charged by adjudicators. This information allows the VBA to monitor whether the adjudication process is meeting the object of the SOP Act.

PUBLICATION OF INFORMATION

The VBA may publish information in a determination if the information does not identify any person or body referred to in the determination or disclose the address or location of that person or body and the identity, address or location of any person or body referred to in the determination cannot reasonably be determined from the information.

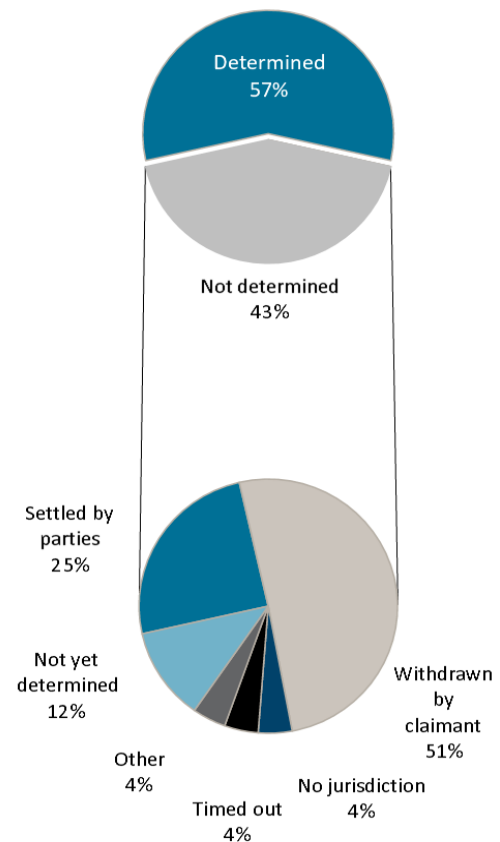


Figure 1: Applications determined vs not determined and reason application not determined for 2019-20 financial year

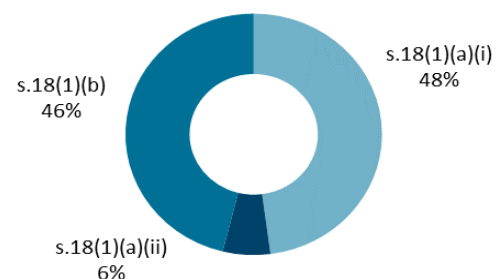


Figure 2: Section of SOP Act under which application made for 2019-20 financial year

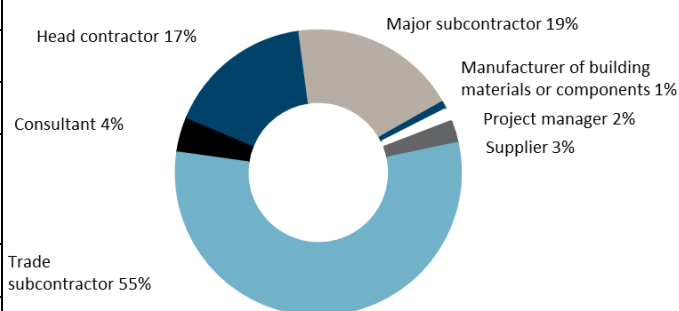


Figure 3: Percentage of applications by Claimant type for 2019-20 financial year

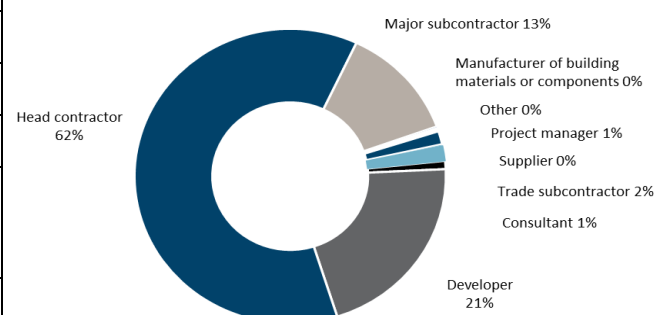


Figure 4: Percentage of applications by Respondent type for 2019-20 financial year

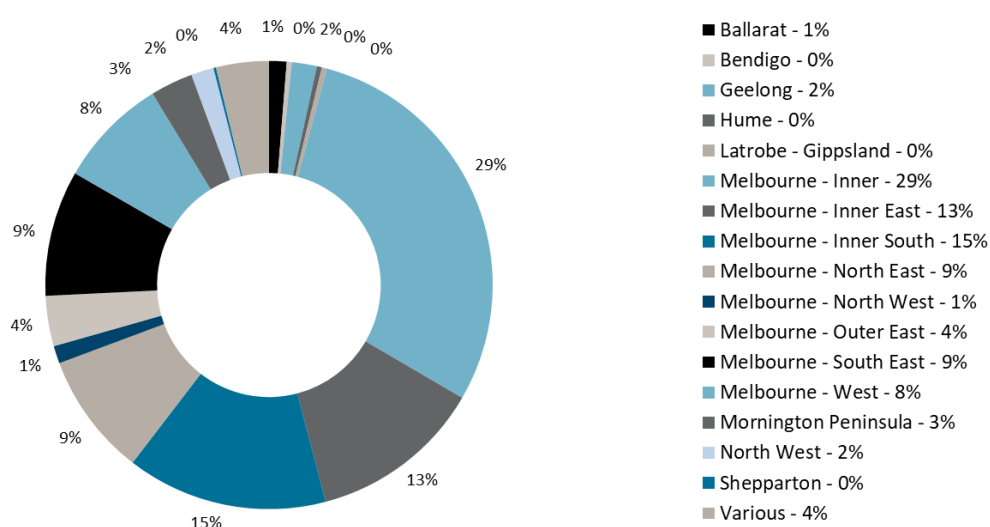


Figure 5: State-wide distribution of applications for 2019-20 financial year

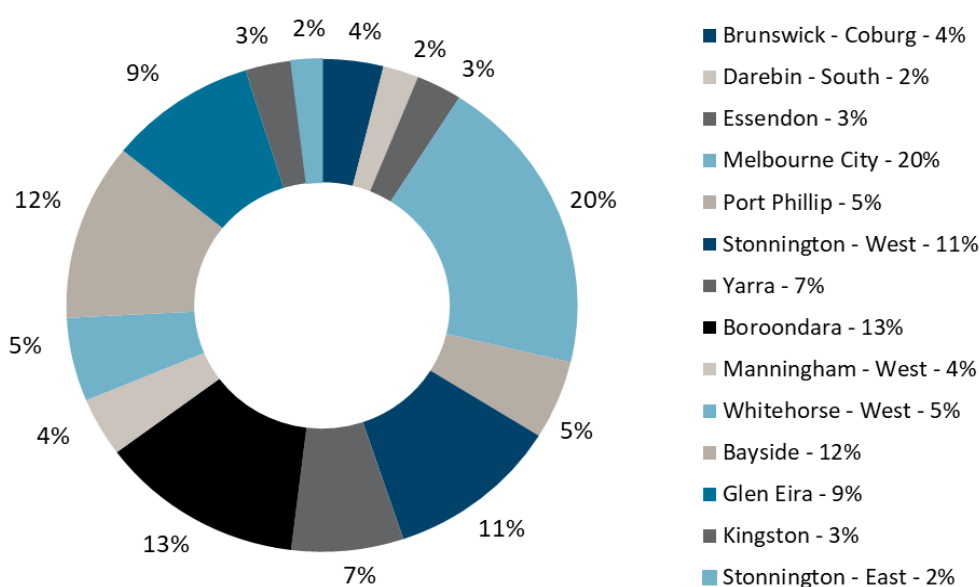


Figure 6: Inner-Melbourne distribution of applications for 2019-20 financial year

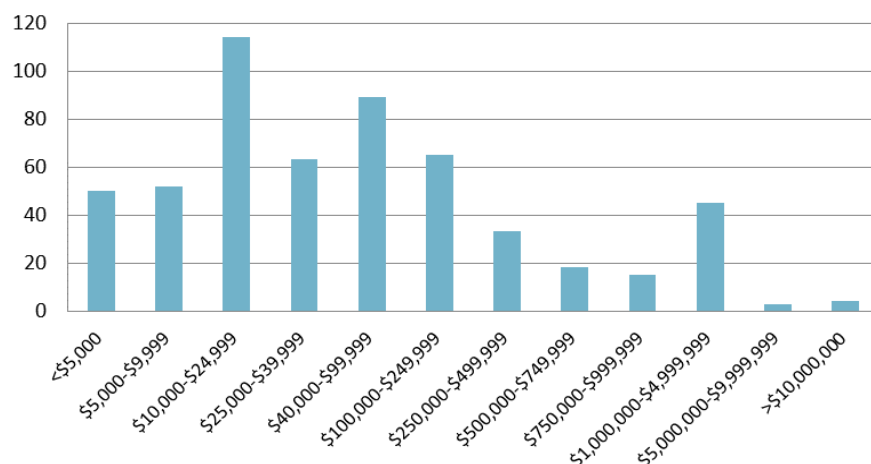


Figure 7: Number of claims by claim range for 2019-20 financial year

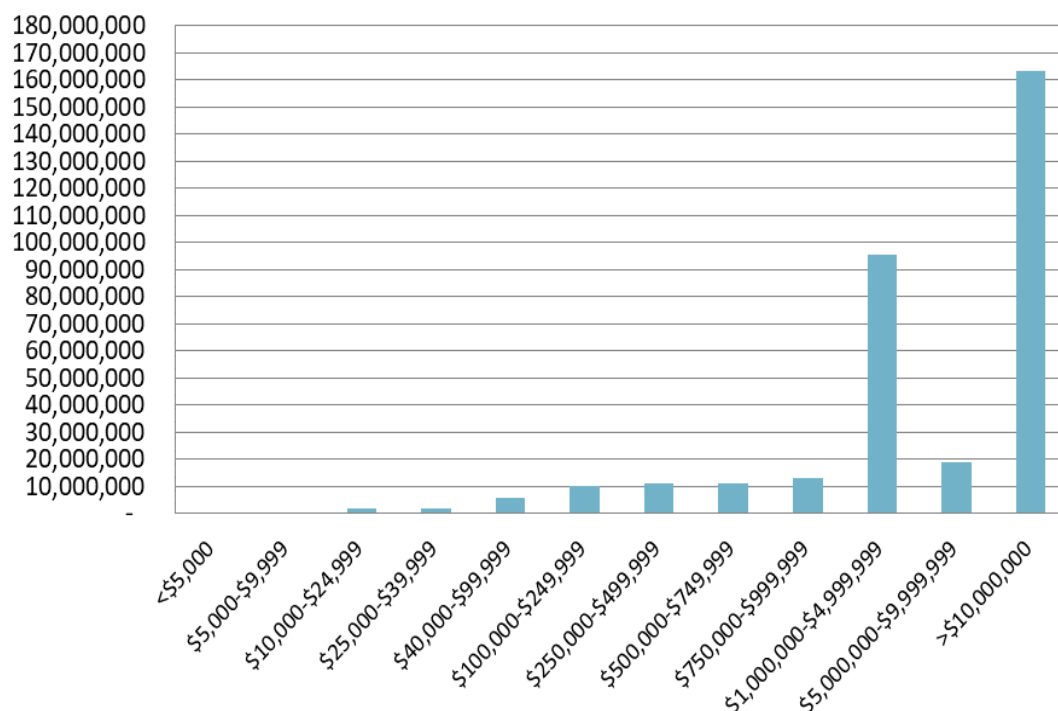


Figure 8: Total sum of claimed amounts by claim range for 2019-20 financial year

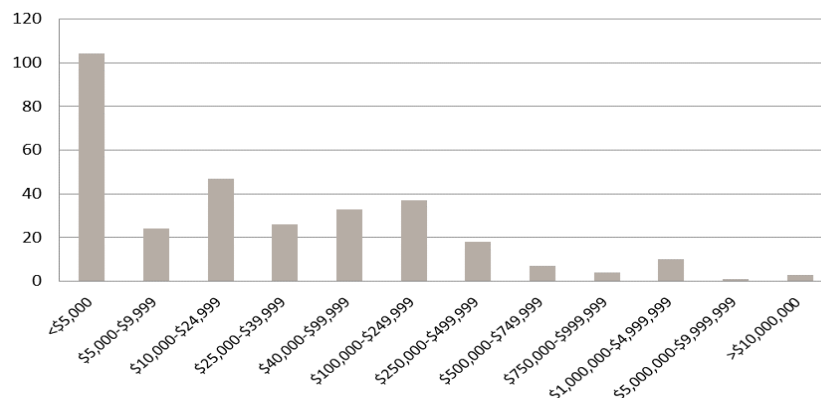


Figure 9: Number of adjudicated matters by adjudicated amount range for 2019-20 financial year

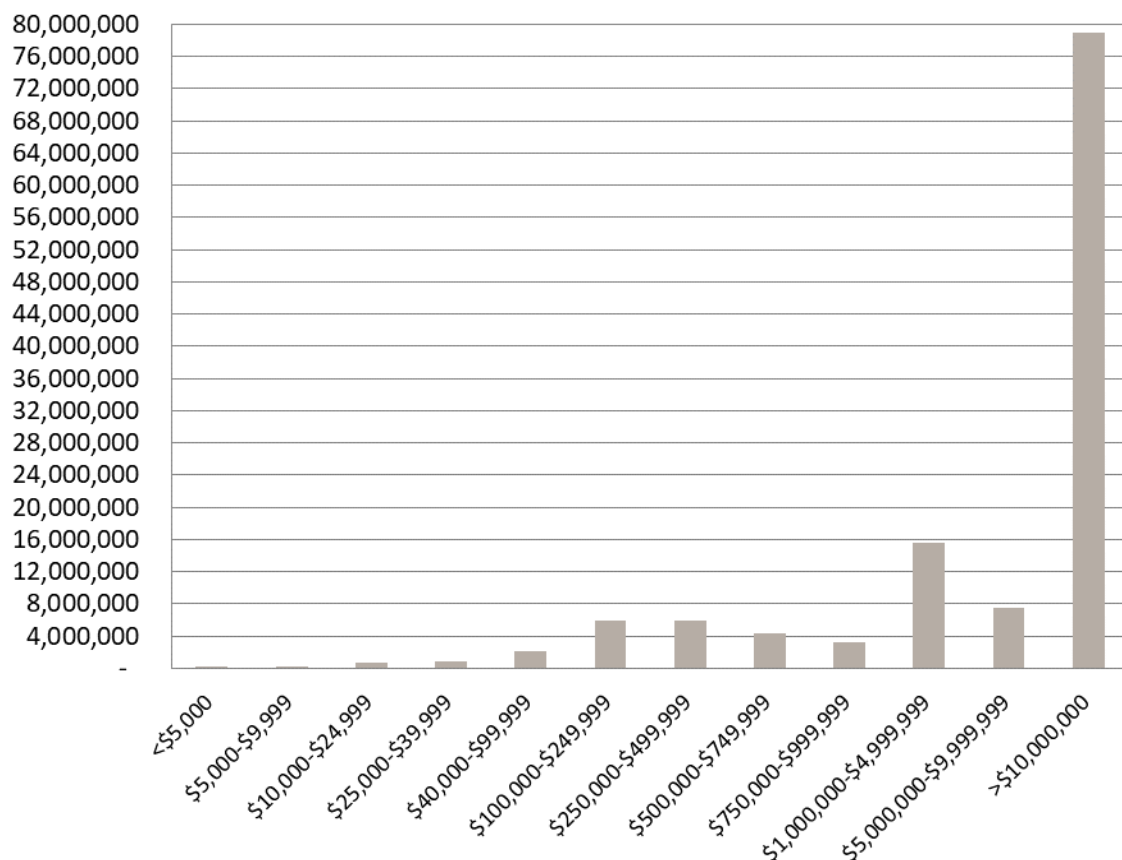


Figure 10: Total sum of adjudicated amounts by adjudicated amount range for 2019-20 financial year

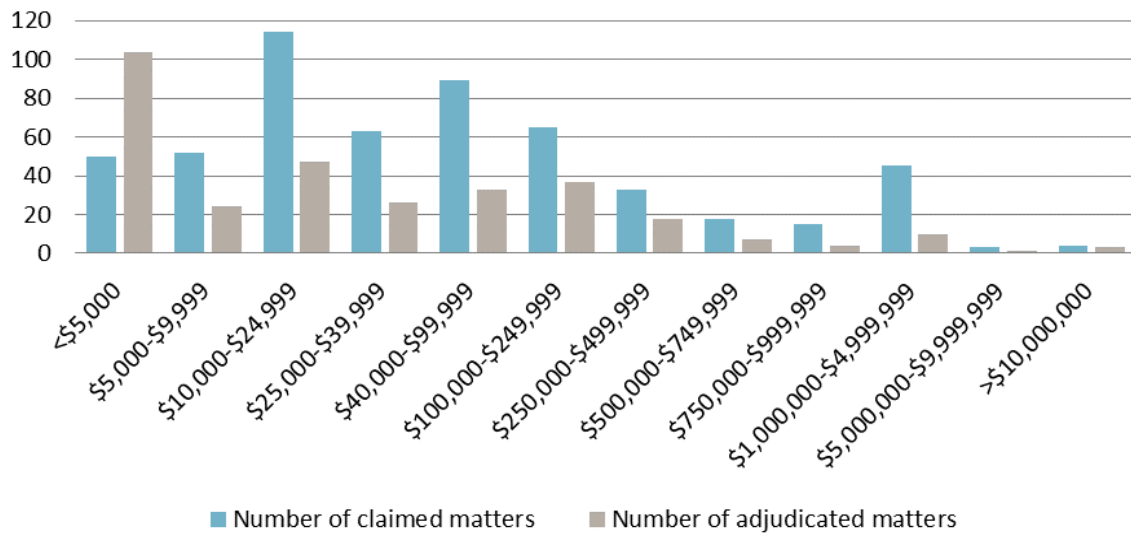


Figure 11: Number of claimed matters versus adjudicated matters by claim range for 2019-20 financial year

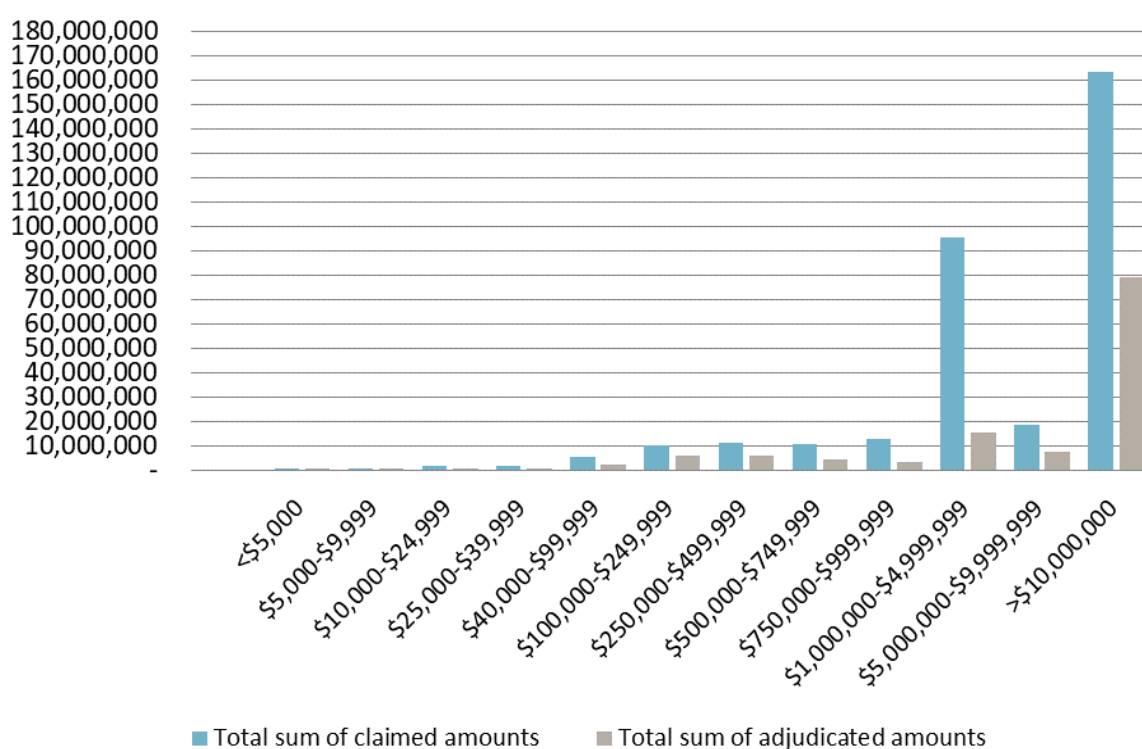


Figure 12: Total sum of claimed amounts versus total sum of adjudicated amounts by claim range for 2019-20 financial year

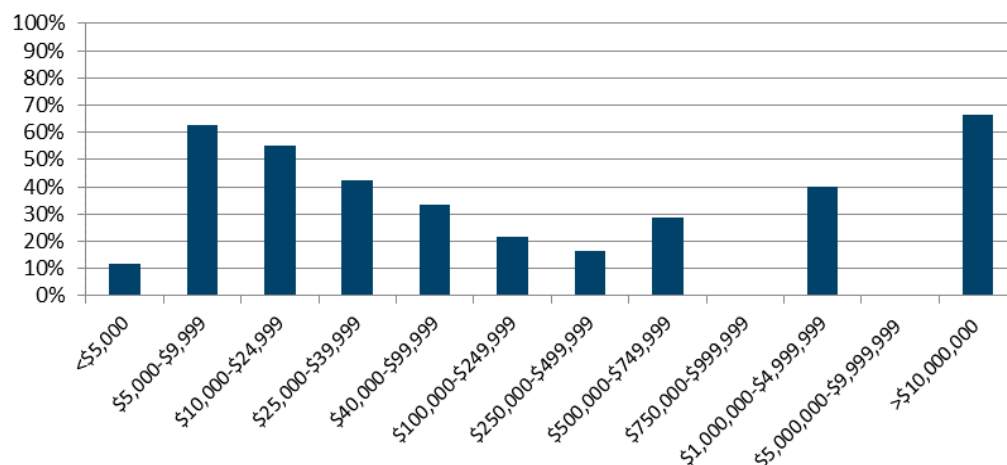


Figure 13: Adjudicated amount as a percentage of claimed amount by claim range for 2019-20 financial year

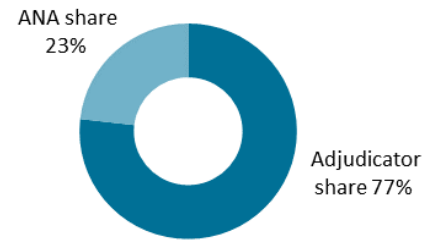


Figure 14: Distribution of Adjudicator fees between Adjudicator and ANA

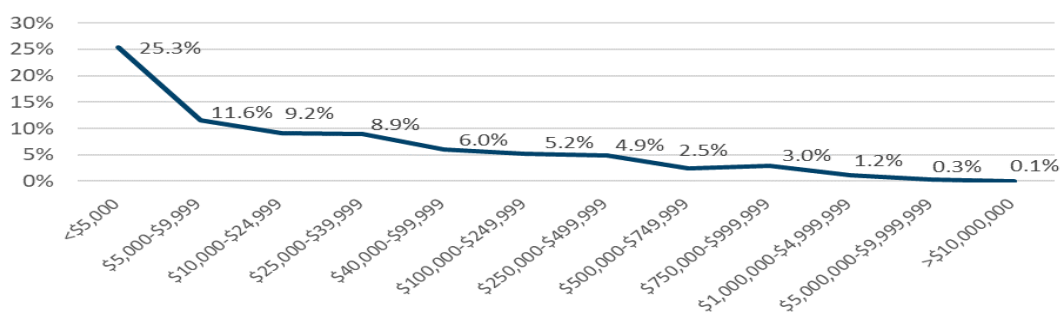


Figure 15: Average adjudicator fee as a percentage of the average claimed amount by claim range (determined applications only) for 2019-20 financial year

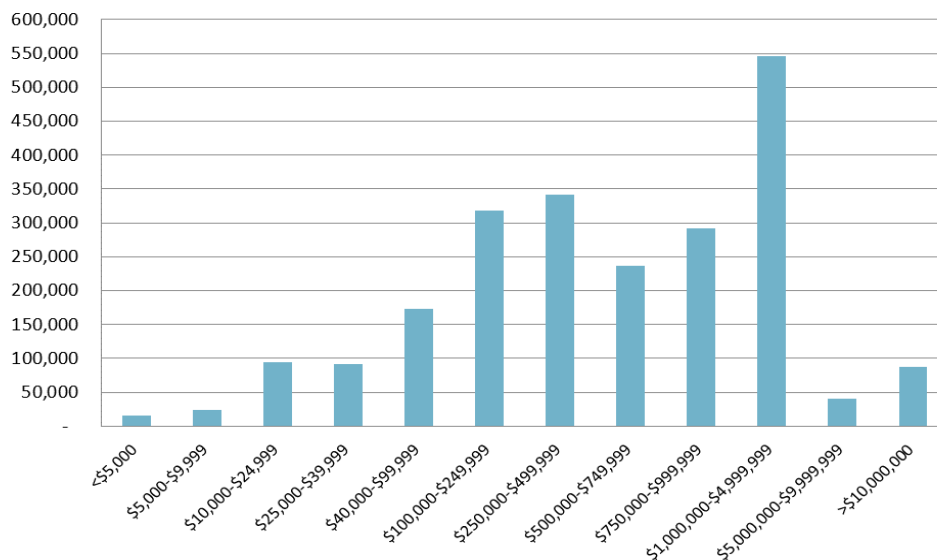


Figure 16: Total Adjudicator fees for completed applications by claim range for 2019-20 financial year

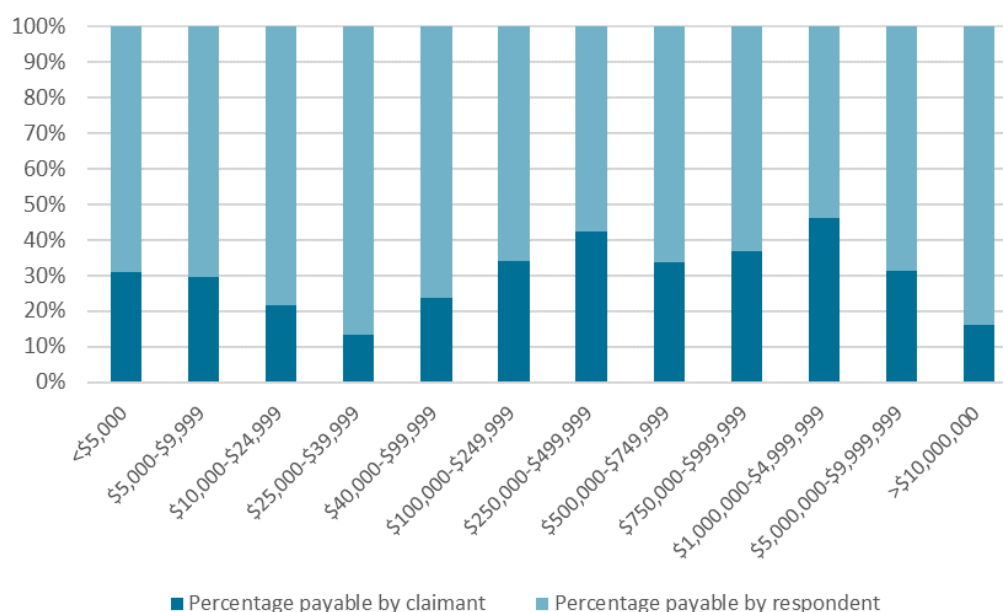


Figure 17: Apportionment of adjudicator fees payable for completed applications by claimant and respondent for claim range for 2019-20 financial year

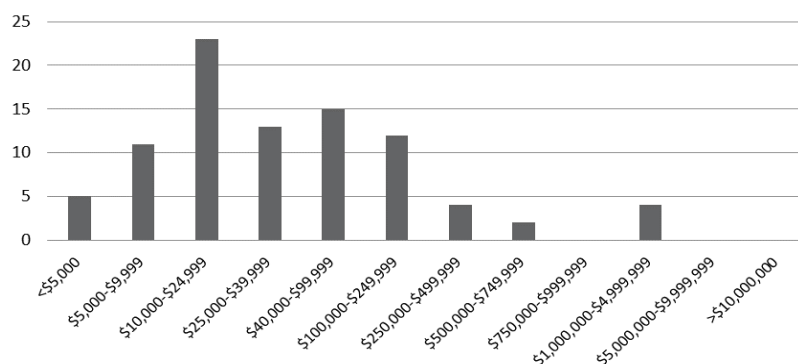


Figure 18: Number of adjudication certificates issued by adjudicated amount for 2019-20 financial year
