## About

The *Victorian Plumbing Regulations 2018* will come into effect on 18 November 2018, replacing the previous Regulations (*Victorian Plumbing Regulations 2008*).

For every class of plumbing, there is number of prescribed, nationally accredited Units of Competency (units).

Once these units are published in Victorian Government Gazette, they are known as 'Gazetted Units of Competency'.

The combination of prescribed units outlines the required skills and knowledge that plumbing practitioners are expected to hold for each class.

It is important to note that plumbing practitioners are generally required to hold a registration or licence in a corresponding main class of plumbing prior to applying for registration or licensing in a Specialised class.

This document outlines the gazetted Units of Competency to meet the needs of the *Victorian Plumbing Regulations 2018* for the following Specialised Classes of plumbing:

1. Backflow Prevention work
2. Thermostatic Mixing Valve work
3. Type A Appliance Conversion work
4. Type A Appliance Servicing work
5. Type B Gasfitting Advanced work

## Specialised classes – 'parent classes'

Before you apply for a registration or licence in a specialised class, you must hold a registration or licence in the corresponding parent class.

If you are seeking to be registered in a specialised class and are not yet registered or licensed in the corresponding class, you should also refer to the 'Gazetted Units Document for Main Classes'.

The following table outlines the parent class for each of the specialised classes:

Specialised Class	Parent Class
Backflow Prevention work	Water Supply work
Thermostatic Mixing Valve work	Water Supply work
Type A Appliance Conversion work	Gasfitting work
Type A Appliance Servicing work	Gasfitting work
