# Overview

## About

For every Victorian class of plumbing outlined in The *Victorian Plumbing Regulations 2018*, the VBA publishes a list of prescribed Units of Competency (units) for both registration and licensing purposes.

The document outlines the units published in April 2021 in the Victorian gazette for both registration and licensing in the following classes of plumbing:

1. Type B Gasfitting (main class)
2. Type B Gasfitting Advanced (specialised class)

### Qualifications that class specific units are selected from

CPC40920 Certificate IV in Plumbing and Services

# Type B Gasfitting (main class)

## Registration

At a minimum, applicants applying via the education pathway must hold:

1. A certificate III plumbing or electrical work qualification, plus
2. A Restricted Electrical Workers Licence (REL) or higher, plus
3. The prescribed class specific unit.

## Licensing
